Research impact

What it is

- Knowledge generated by your research makes a difference
- Taking study results outside academia
- Examples of impact: policy, practice, economic, regional.

What it is NOT

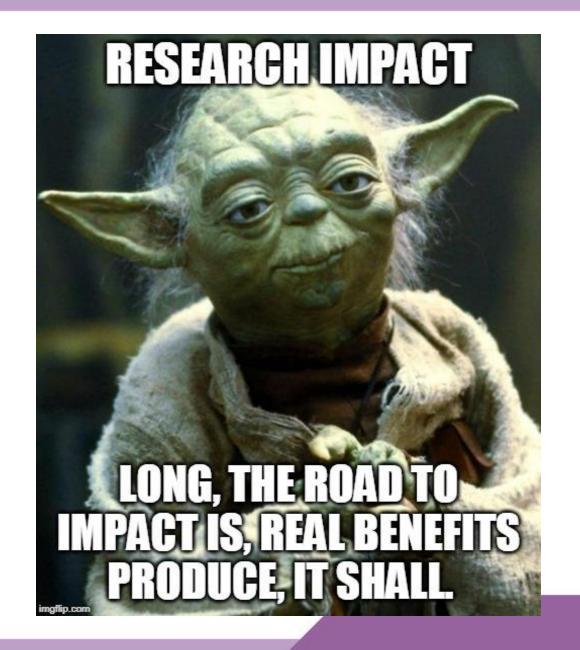
- Press release
- Dissemination event
- Meeting with stakeholders

AND does not include any real-life benefits!



Why is it challenging?

- Many researchers don't know where to start.
- Your research is scrutinised by practitioners – facing difficult questions.
- Time- consuming process and no guarantee that it will produce any result.

Key messages

- Scotland holds a critical advantage over the rest of UK in this regard but still faces challenges.

Engaging with stakeholders

- Who are the key stakeholders?
- Why would they be interested in your study?
- Quality versus quantity
- How much time they have to support you?
- How to approach them?





Exercise: Who are your key stakeholders?

- Identify 2-3 stakeholders who can help you with your research impact
